Pursuant to Regulation 30 read with Schedule III of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015, we hereby inform you that the Company has entered into a sub contract for the supply, installation and maintenance of solar powered agricultural pumps to farmers in Maharashtra under the government of India's Kusum Yojana. Our principals for this project have signed contract with Maharashtra government for 5,000 sets worth approximately 150 cr. Ishan has initially received a part of it and revolved 3 times in a financial year this would mean a contribution of additional 18 cr in our turnover.

On similar lines Ishan is also trying to get similar projects in other states as well. This will result in exponential growth for the company in the immediate future leading to nearly doubling of the present revenue. Vietnam has been one of the traditional markets for us for over 25 years and with the help of advanced technical know-how and technology we are well set to receive several projects in Vietnam in renewable energy sector specially in Hydro Power and Wind Energy. This indirect export will result in rapid growth in Ishan's profits for years to come. Further, marketing efforts have been strengthened manifolds in our other traditional markets such as Philippines and Indonesia and this will give boost to our business in south east Asia. Ishan has also made forays into America and east Africa and starting the next financial year we expect positive results from these markets as well.

This strategy for growth and diversification combined with a well-developed execution plan we are well set to achieve sustainable growth on a long-term basis. During the financial year 2024-25 we expect to achieve a sales revenue of over Rs 70 cr or a growth of nearly 100%. As we grow, we remain committed to making positive contributions towards environment and climate control.
